In consideration of my participation in the event **"IRHA Futurity – 2026 – ITALIAN NATIONAL CHAMPIONSHIP 2026"**, I hereby expressly authorize the Italian Reining Horse Association and the Organizing Committee of the event to process my personal and sensitive data pursuant to Legislative Decree 196/2003 and European Regulation 679/2016.

I further expressly authorize them to publish and/or distribute, in any form and/or through any medium (for example, websites, social media, printed materials, video streaming, etc.), photographic and video material produced during the event that features myself and/or my horse(s), waiving any right to object.

I declare, under my personal responsibility, that **I have taken out an insurance policy covering any damage suffered by me and/or my horse(s)**, as well as any damage, injury, or personal harm caused by me and/or my horse(s) to third parties during the event. Any lack or insufficiency of the aforementioned insurance policy will result in the loss of my right to file claims for compensation against IRHA and the Organizing Committee.

I further undertake to address any claims for damages suffered by me and/or my horse(s) during the event exclusively to my insurance company or to third parties other than IRHA and the Organizing Committee, thereby releasing IRHA, the Organizing Committee, and all of their officers and representatives from any liability for incidents or injuries suffered by me and/or my horse(s), as well as for any damage caused by me and/or my horse(s) to third parties (injuries, personal harm, and the like) during the event.

This declaration shall also serve as a waiver of any right of action against IRHA and the Organizing Committee, as well as of any claim for indemnity, recourse, or guarantee against them for facts occurring during the event.

I confirm that I will comply with the IRHA-FISE guidelines regarding the event regulations, Animal Welfare rules, and Steward procedures (see the IRHA-FISE website I confirm that I have read and fully understood the present waiver and, by signing it, I unconditionally accept the above-mentioned rules applicable to all horses, riders, and owners listed in the registration form.

I further declare, by signing this document, that I am of legal age or that I am the parent/legal guardian of the minor registered for the Reining competitions. "By submitting this reservation, I accept the IRHA-FISE-NRHA regulations attached to this form in their entirety.

PARTICIPATION RULES

Below are some simple guidelines; full details can be found in the official event regulations. You may register exclusively online through the website www.showmanager.eu. All horses participating in the Futurity (3- and 4-year-olds) and in the ancillary classes must hold a valid NRHA Competition License and an NRHA Membership Card valid for 2026. Those who do not yet have them are kindly requested to apply in advance through the NRHA Association. Full instructions are available on our website.

As required by NRHA regulations, no competition licenses may be issued at the show, since the NRHA office will not be present on site. A veterinarian will also check FISE passports.

No horse without a valid, renewed FISE passport will be allowed to take part in the event.

NRHA IRHA IRHBA FUTURITY 3 Years Old 2026

Competition reserved for three-year-old horses. (Horses must be shown one-handed). **Only the offspring of stallions enrolled in the IRHBA Breeding Program for the 2022 breeding season, or foals individually enrolled, may participate in the "3-Year-Old Futurity 2026" for the four proposed levels.** (The complete list can be found at www.irhba.com). The Non Pro Futurity will take place in one Go Round plus a Final, and a "Consolation" category (pattern 13) will be offered for all four levels: horses that do not achieve a score sufficient to qualify directly for the Final may enter this category. (For the number of riders eligible to enter the Consolation, and the number who may, depending on their score, advance to the Final, please refer to the 3-Year-Old Non Pro Futurity conditions). For all regulatory details, please refer to the attached Conditions of Participation. As regards the **IRHA Futurity Over 50 Prime Time Non Pro/Open – Youth categories**, a Final will only be held if there are at least 5 participants per category. Otherwise, the best score from the first Go Round will determine the winner. 40% of entries (beyond the 5 participants) will advance to the Final. (For Youth/over 50 Op&NP, no Consolation will be offered. For Over 50 Open, the combined scores of the 1st and 2nd Go will determine qualification for the Final). To enter these categories, riders must also be entered in the IRHA NRHA Futurity at their corresponding levels.

NRHA IRHA IRHBA FUTURITY 4 yrs old 2026

Competition reserved for 4-year-old horses. **Only horses eligible for the respective 3-Year-Old IRHBA Futurity or nominated to the IRHBA Derby may participate for the four proposed levels.** (Horses must be shown one-handed) which will be held in one go-round plus a final for the proposed levels. No consolation round for these classes. Regarding the FUTURITY IRHA 4 Y OVER 50 PRIME TIME NON PRO/OPEN – YOUTH categories, a final will only take place if there are at least 5 participants per category. Otherwise, the best score from the first go-round will be awarded. 40% of the entries (beyond the first 5 competitors) will advance to the final. To enter these categories, it is mandatory to also be entered in the IRHA NRHA Futurity at the corresponding levels.

The entry lists of the registered horses will be published before the start of the competition. **Up until the day before the competition** (official draw publication), the show office reserves the right to make changes (such as cancellations, rider or owner changes). However, the published positions of the registered horses may not be altered.

Any additional entries will be placed at the beginning of the starting order (-1).

Should a Non Pro rider wish to enter the **3-Year-Old Non Pro Futurity**, they must notify the show office **by 6:00 p.m. on Friday, November 6.**

The starting order for all finals (Futurity 3-year-olds and Futurity 4-year-olds) will be based on scores obtained in the qualifying go-rounds. (The highest score will start last). According to NRHA rules, riders with more than one qualified horse must have at least an 8-horse gap between their runs, provided the number of qualified horses allows this. and in any case the maximum interval possible. It will not be permitted, however, to enter either the preceding or the following section other than the one to which the rider is qualified.

For stall reservations, please complete your registration online at www.showmanager.eu by the deadline. Stalls booked and canceled after (October 20) must still be paid at the cost of €175.00.

Paid live streaming will be available for Futurity 3- and 4-year-old classes (go-rounds and finals). Each owner of a horse entered in the Futurity 3- and 4-year-old classes will receive a personal access code to view the event for free. For the Italian Championship classes, streaming access will be free for all users.

The contents of the following sections will be published in final form on www.irha.it closer to the event date, while preliminary health requirements may still be subject to changes or adjustments as required by the authorities. A provisional map showing the warm-up arena layout is attached.

EQUINE HEALTH CERTIFICATES:

Infectious Anemia (Coggins Test): The test is mandatory for all horses (one year validity)

Specifically:

- The Coggins test with a one-year validity is required for all horses coming from abroad.
- Young horses under three years of age must still have had a Coggins test during their lifetime, except for foals under six months old, who are exempt.

The test result must be recorded in the horse's identification document, with the stamp and signature of the competent local veterinary authority.

Equine Influenza: All equines must present certification of influenza vaccination with a cycle completed at least 30 days before the event.

STABLE CODE: 036CR01M.

For any updates to the rules concerning the event, please refer to further communications published on irha.it and futuraity.it.

All horses may access the Fairgrounds starting **Wednesday, November 4, 2026, from 8:00 a.m.** **Access to the competition arenas will be allowed from 6:00 p.m.** on Wednesday, November 5. No entry or use of the arenas will be permitted before these dates and times.

All horses must wear their back number and riders must wear the event wristband when entering and remaining in the competition and warm-up arenas. Starting orders will also indicate the official timetable for use of the main arena and warm-up arenas. To ensure optimal use of the warm-up arenas for riders, each horse-rider pair may be assisted by no more than two helpers. For the finals, a special access pass may be issued if necessary. During both day and night, the warm-up and competition arenas will be supervised. **Stewards are authorized to stop or suspend a competitor's run** if needed. Farrier and veterinary services will be available, as required by the rules, from 30 minutes before the start of each competition day until its conclusion. An ambulance and first-aid service will be present only during the competition classes. Outside those times, the Organizing Committee is not responsible for incidents involving riders or spectators. Emergency phone numbers will be posted on the door of each stall.

It is mandatory to provide the entry forms for all horses participating in the Futurity and the Italian Championship categories. At the show, you may make any necessary changes or add classes. **The pre-registrations for the Ancillary classes** must be communicated at the closing of registrations but **must still be paid in full even if cancelled** before the competition. All reservations submitted without entry forms will be rejected.

For NRHA ancillary classes, no schooling runs will be allowed; participants must follow only the official run and its duration must not exceed 4.5 minutes.

ADDITIONAL ENTRIES DURING THE EVENT MAY NOT BE ACCEPTED ON SITE Dogs must remain at campers/vans or inside their tack rooms. They may not roam freely in the fairgrounds. During movements, dogs must always be kept on a leash and the nearest safety gate (located behind the stalls) must be used. All riders must hold a valid 2026 FISE license or, for foreign riders, a guest license, and must have personal insurance coverage.

Bank checks will not be accepted on site. Anyone who has not yet submitted the IRHBA free-entry certificate must send it together with the stall reservation form. The free-entry discount will be applied to your pro forma invoice, which will be sent as confirmation of your entry.

Prize money will not be paid at the show: please provide your IBAN on each entry form so that any prize money you earn can be processed within the scheduled timeframe. (Prize payments will only be made after the results of mandatory anti-doping tests, and will be subject to applicable tax withholdings).

During day and night, the warm-up and competition arenas will be supervised. Stewards are authorized to stop or suspend a competitor's run if necessary. Farrier and veterinary services will be available, as per NRHA regulations, from 30 minutes before the start of each competition day until its conclusion. Ambulance and first-aid service will be guaranteed only during the competition classes. Outside of those times, the Organizing Committee is not responsible for incidents involving riders or spectators. Emergency phone numbers will be displayed on the notice board.

For each reserved stall, one pass will be issued for unrestricted access to the facilities. In addition, by Friday, November 13, each participant will receive an admission ticket for the Open finals scheduled on Saturday, November 14.
