PROCEDURES FOR THE PREVENTION OF COVID – 19

Prior to attending the event

Each individual that is allowed to enter the premises of the event must:

- 1) **Fill in the individual registration online form** named “DERBY COVID-19” which can be found on www.salonedelcavallo.com.
The following is requested in the above mentioned form:
 - a) Personal data.
 - b) Reason for requesting entrance.
 - c) Declaration of absence of symptoms relative to COVID – 19.
 - d) GREEN PASS or negative RAPID COVID test performed 48 hours prior to entry at the event (please note that upon arrival at the fairgrounds it is possible to be rapid COVID tested organized by the organizers with costs paid by individual users).
N.B. Copy of the Green Pass or test result must be uploaded.
 - e) Documents and forms must be approved.
- 2) **An identification document will need to be presented** in order to verify the data submitted as per above described procedure.
- 3) **Undergo individual temperature measurement.**

During the event

Each individual must:

1. **Wear a mask** in all closed or covered premises.
2. **Maintain social distancing of at least 1 meter** with individuals that are not part of their family unit.
3. Sanitize or wash hands frequently.
4. Scrupulously observe rules issued by prevention and control personnel.
5. Stay within the facilities for the minimum time necessary for training and/or competition sessions.
6. Avoid contact and accidental contact with other people.
7. **In one's stable** (stalls assigned for the event) **follow all prevention rules** designed to avoid contact between individuals or surfaces exposed to handling. For example, disinfect saddles, bridles, products for the cure and hygiene of the horse each time they are used and prevent the use of these by other; use single-portion drinks marked with your name, etc.
8. **Should signs pertaining to the pandemic appear, immediately contact the event medical personnel** and follow the indicated procedures. Immediately invite members of your family unit to avoid any form of contact with others.
9. Please advise personnel in charge about any non-compliance to regulations by others present inside the premises.
10. **Have your temperature measured daily** by medical personnel present at the venue.
11. Pets must be kept in own campers or in own stalls.
12. Testing. During the event, and upon individual request, it is possible to be rapid nasal COVID tested at the venue and/or at a private laboratory in Cremona (costs will be charged to the user).

INFORMATION ON PERSONAL DATA PROCESSING

Pursuant to EU Regulation no. 679/2016 (GDPR), information is provided below regarding the processing of personal data of subjects participating in sporting events under the FISE until July 31, 2021.
Data controller:

Type of personal data processed and of interested parties

Within the limits of the purposes and methods defined in this information, the following are processed:

- a) data relating to body temperature;
- b) data relating to non-submission to quarantine measures.

The personal data being processed refers:

- a) to members of the Italian Equestrian Sports Federation (FISE). With respect to these interested parties, this information supplements that already provided for the processing of personal data functional to the establishment and execution of the employment relationship
- b) to the collaborators of the Organizing Committee.

Purpose and legal basis

Personal data will be processed exclusively for the purpose of preventing contagion EHV contagion. The legal basis of the processing is, therefore, found in the implementation of the guidelines.

Nature of the provision of personal data

The provision of data is necessary to participate in competitions under FISE until May10, 2021.

Method, scope and duration of the processing

The processing is carried out by staff and / or collaborators of the Organizing Committee and / or FISE – should information be transferred. With reference to the measurement of body temperature, no data recording is required. The identification of the interested party and the recording of the exceeding of the temperature threshold could take place only if it is necessary to document the reasons that prevented access. In this case, the interested party will be informed of the circumstance. The data will be processed for the time strictly necessary to pursue the aforementioned purpose of preventing the EHV infection and will be kept on file by the Organizing Committee no longer than the term provided by federal guidelines. Personal data will not be disseminated or communicated to third parties, except on the basis of specific regulatory provisions (eg in the event of a request by the Health Authority for the reconstruction of the chain of any close contacts).

Rights of interested parties

At any time, interested parties have the right to access their personal data, to request corrections, updates and relative cancellation. It is also possible to oppose the processing and request its limitation. These requests can be addressed directly to the Organizing Committee. Furthermore, in the event that it is believed that the processing has been carried out in violation of the legislation on the protection of personal data, the right to lodge a complaint with the Guarantor Authority (data protection authority), Piazza Venezia, 11 - 00187 - Rome is recognized.
